## Fifty-Ninth Annual Parish Meeting of The Church of Christ the King Episcopal 6490 Carr Street, Arvada, Colorado 80004 January 31, 2021 held via Zoom

**Opening Song and Prayer:** The 2021 Annual Parish Meeting opened with the congregation joining in to sing "The Servant Song" (verses 1 and 2) led by Andi Smith on the piano. Rev. Margaret began the Zoom meeting with a prayer.

**Proof of Quorum:** Barbara Jennings, Jr. Warden, confirmed that there were sufficient church members present for a quorum.

**Call to Order:** Rev. Margaret Peel-Shakespeare (Interim Priest) called the meeting to order at 10:30 a.m.

Rev. Margaret thanked Jessica Starbird, Andi Smith and Jeff Smith for their help in preparing for the annual meeting. The 2020 Annual Report was distributed via email on January 21, 2021 so that parishioners would have an opportunity to review the information prior to the annual meeting. Special recognition was given to Martha Jones for her work on updating the CTK website. Rev. Margaret reminded members how to vote for approval from within Zoom.

**Approval of the Minutes of the 58<sup>th</sup> Annual Meeting:** A motion was made to approve the minutes from the 58<sup>th</sup> Annual Meeting held on January 26, 2020. The motion was seconded and approved.

Clergy Report: Rev. Margaret reviewed the transition process with the congregation. The process was explained using the screen to share the timeline provided by the Diocesan Office of Transition Ministry. Rev. Margaret mentioned that we are currently about one-quarter of the way through the sequential steps. The formal search process will begin this coming spring when the Vestry will appoint the members of the Search Committee. This committee will work to gather the documents and information necessary to prepare the Parish Profile used to advertise the rector position and gather applicants. The Search Committee will reach out to parishioners for their input throughout this process through focus groups, and this committee will conduct interviews of potential candidates. The Search Committee will then recommend candidates to the vestry; the final candidate is selected by the Vestry.

**Presentation of the 2021 Budget:** Bob DeLong began by thanking all those who participate in our parish financial activities as follows: Our bookkeeper, Ros Patterson; our tellers who perform the weekly count and posting of contributions under the leadership of Cathie Craig; the members of the Finance Committee; the members of the Audit Committee, and all our generous parishioners. He noted that the financial documents for 2020 and also the proposed budget for 2021 were contained in the Annual Report distributed via email prior to this meeting.

Bob DeLong mentioned that 2020 had been a good year for Christ the King, with income about \$3,000 over expenses. CTK did receive \$23,600 in funds through the Payroll Protection Plan which helped us greatly. Bob mentioned that the annual financial information was reviewed by both the Finance Committee and the Vestry in advance of this meeting. Bob stated that we have a balanced budget for the preliminary 2021 budget using a conservative approach. The financial status of CTK will be checked on a month-by-month basis. He also mentioned that the proposed 2021 budget included \$3,000 for the search process.

Motion: Mark Molello moved to accept the 2021 Preliminary Budget as presented. Daniel Ohamaka

seconded the motion. As there were no objections or abstentions, the motion was approved by those attending the Zoom meeting.

Rob Jones offered special thanks to Robert DeLong and Ros Patterson for their hard work.

**Recognition of Outgoing Vestry Members:** Rev. Margaret offered special thanks to our two outgoing CTK Vestry members, Linda Palmer and Daniel Ohamaka. Linda Palmer has completed two and a half terms, and Daniel Ohamaka has completed his three-year term. CTK thanks them both for their contributions and years of service. Both members are invaluable and are greatly appreciated.

**Presentation of the Nominating Committee Report:** The Nominating Committee recommends the following individuals for the 2021 CTK Vestry positions:

- Barbara Jennings, Sr. Warden
- Bob Mickelson, Jr. Warden
- Rick Atkinson, nominated for open vestry member position.
- Nancy St. Pierre, nominated for open vestry member position.

Candidates Rick Atkinson and Nancy St. Pierre each prepared information about themselves which has been included in the weekly. Special thanks were offered to Rick Atkinson and Nancy St. Pierre for volunteering to serve on the Vestry beginning February 2021.

**Election of 2020 Vestry Members:** Ros Patterson moved that the proposed slate of candidates be approved as presented. The motion was seconded by Kit Ryan. The Nominating Committee slate of candidates was approved as presented as there were no abstentions or objections.

Amendment of Articles of Incorporation, Section 7.5 Distributions of Endowment Funds: Rev. Margaret reported that the amended Articles of Incorporation (approved by the congregation under Rev. Becky last October 2020) have been returned by the Diocese because of concern over the percentage of numbers required of various groups for approval wording in Article 7.5 Distributions. The Diocese is suggesting that CTK change the wording of the percentage of approval to (3/4 across all groups) in order to avoid problems in the future.

The Vestry has approved this recommended change; however, this change cannot be accomplished to-day because Article 11.5 requires a 30-day notice to the congregation on the vote. CTK will provide the notice, share the details of the proposed change, and set the date to hold a special parish meeting to accomplish this. This information will be posted on our website and also distributed through email.

**Adjournment:** The meeting adjourned at 11:12 p.m.

**Closing and Prayer:** The meeting ended with the congregation singing verse 3 of "The Servant Song." Rev. Margaret closed the meeting with a prayer.

#### **RECTOR'S REPORT**

Dear Christ the King,

What a year 2021 turned out to be among us. We have experienced a lot in the past year including loss and joy in the lives of each other. We began the year solely worshipping online and at the end of May we were able to open our chapel for limited seating and in-person worship. Hearing you all sing and pray aloud was such a gift since that was the first time I had gathered in-person with you to worship, because of the pandemic. In June and July we worked with our HVAC company to improve the airflow in our nave and we were able to increase our numbers and meet in the nave again. We met successfully for six months inperson keeping up with the protocols of masking and distancing, etc. This past year we also learned how to live-stream our services via YouTube which has made it possible for many others to attend from home. Special thanks for Phil Goodman for all the hard work he has put into this process. Jessica Starbird, Rachel Mondragon, Frank Hester and Barbara Jennings have also given of their time to learn the process and help us with sound and tech for live-streaming. Thank you all for making this possible!

While we are currently not meeting in-person, due to the rise in covid cases even among our parish and families, we are still connected. We now know from experience that this covid "wave" will not last forever. Our goal is to resume live-streaming when the covid numbers decrease and when the time is right to re-open for limited seating.

This year has been marked by many things including improvements to our building such as updating thermostats and CO2 monitors in our nave to increase the air flow in that space. With the formation of a Property Committee we were able to focus on some special projects and much needed maintenance to our buildings and grounds. This includes the recent mold remediation/water damage in the office area and HVAC updates. Special thanks to Mike Paugh for chairing this Committee; Mike Paugh, Steve Barritt and Larry Healy serve as members of our Property Committee. Thank you to Mike, Steve and Larry for all the hours they have spent preparing the building or waiting on work to be completed. We are most grateful to you for keeping up with this!

Many of the improvements and maintenance to our church building have resulted in difficulty finding supplies and labor so most of these projects have taken longer than expected. However, we are still focused on completing the projects we have started and keeping up with needed maintenance.

The carpet project has also made progress! As you know, the carpet samples have been on display and the Property Committee is currently working with the Carpet committee to secure pricing and a bid for the work to install carpet in Kempsell Hall and the offices.

I want to thank outgoing vestry members Amanda Roberts and Robert DeLong for their service on the Vestry. In addition, I would like to thank Peggy Broderick for serving as Clerk and Robert DeLong for serving as our treasurer. Both have served faithfully for over five years now. Thank you for giving of your time and gifts to the church!

Your Search Committee has worked very hard this year to listen to your feedback from the survey, to complete the parish profile and to begin the interview process all with the help of the Diocese. Michelle Bredine, your Search Committee Chair, will give an update at the Annual Meeting and be sure to check out her update in this report.

Thank you for your prayers this past year. This is the year when you will call your next rector and it is a time to prepare yourselves for that work and new ministry at Christ the King. I would ask that you continue to pray for your church leadership during this time. Please pray for your Interim Rector, Wardens, Vestry members your Search Committee members and for the new Rector who will be selected this year. May we all be guided by the Holy Spirit during this transition.

#### Senior Warden's Report

We started 2021 with the aim of regathering in the church building for worship services. After almost a year of worshipping over Zoom, we wanted to meet together again. Following Diocesan guidelines, we

wanted to have adequate airflow to make the space safe to meet. We had a three-phase plan to safely enter the church building again. The biggest hurdle was to make sure the airflow was sufficient to keep the air circulating to ameliorate the danger of passing the Corona -19 virus. We would wear masks and social distance as well.

Phase I -- Meet with 25 people in the Chapel where we could open windows and run the fans.

Phase II -- After some upgrades to the circulation, meet in the Nave with 75 people. We marked the pews with blue x's to indicate the social distancing.

Phase III --After some work to circulate the air in Kempsell Hall, we could meet for social groupings like Coffee hour.

We achieved Phase I by the end of May. And we were back in the Nave by the end of June. We were able to hold funerals and Sunday worship services. We did have Coffee hours and Receptions after funerals in the parking lot under tents. We have yet to clear Kempsell hall, but expect that could happen soon. After many months of Zoom services, it was decided to livestream the service through Youtube. We purchased cameras to improve the online services by livestreaming.

Another major effort for 2021 was to appoint a Search Committee and prepare to interview applicants for our new rector. With Michelle Bredine as chair, we did have a Search Committee set by April. They worked throughout 2021 to prepare a profile for the church and post it. By November, we had an active posting for new rectors to review and apply. We extended the posting through December and the Search Committee to complete interviews by February 2022.

Property Committee completed projects to enable our reopening and continue our efforts to replace the carpet in Kempsell Hall and the Offices of the church.

While we could start the worship regathering. Other groups continued to meet via Zoom. Friday morning prayer, Wednesday Compline, Crafters of the King, Conversations on Racism and Reconciliation, Climate Care Tesm and Bible Study. Vestry has met on Zoom as well. We have not yet invited outside groups to meet in our building either.

While we couldn't hold our Neighborhood Dinners in the church, we continued to provide what outreach that we could. Mark Molello continued to help at St Clairs table. We provided money to bring Bibles to prisoners instead of the traditional turkey shoot. And we provided for the Rising in Arvada. We continue to collect our Monthly open offerings for specific outreach needs.

We lost one Vestry Member this year to cancer. Kit Ryan's funeral was held in the Nave on Jun 29,2021. We greatly miss his work on the Vestry. I also want to offer my thanks to our retiring Vestry members for their dedicated service: Bob DeLong and Amanda Roberts.. I want to thank Peggy Warren for her service as Clerk of the Vestry and Bob DeLong for his faithful service as our Treasurer.

## **Junior Warden's Report**

As with everything else in our lives over the past two years, COVID had an impact on the facilities here at Christ the King.

Soon after appointment of a new Junior Warden in April, a Property Committee was set up. This committee consists of Mike Paugh (Junior Warden), Steve Barritt, and Larry Healy.

After doing church via various Internet resources for over a year, we began looking for ways to get back to meeting in person. One of the first actions was to clean up the old church sanctuary and get it ready for in-person services. Thanks to a great bunch of parishioners who dedicated a Saturday to helping out, we were able to clean the chapel out and begin meeting there in late spring. The windows and ceiling

fans in the chapel allowed us to provide the required outside air and airflow for meeting in person.

In order to facilitate streaming our services to those who couldn't come to church, or who chose not to, we upgraded out wireless network infrastructure to support the video cameras and other equipment needed to make the services accessible online.

This was a good start, but the space in the chapel was quite limited and we needed more room as more people felt ready to come to in-person services. COVID guidelines stated that airflow and air "turnover" was important for meeting spaces. This led us to work with our HVAC contractors to evaluate the status of the systems serving the nave and narthex. That evaluation discovered that some of the equipment was not up to the task and we had to do some work on those systems in order to open up those spaces for inperson meeting. That mechanical work has been completed and includes new CO2 sensors and thermostats for better control. Steve Barritt of the Property Committee provided great guidance on this project.

Concurrently with the HVAC work, we repaired the water damage and mold that was in the storage room and former youth minister office. Larry Healy of the Property Committee worked to get bids and monitor the progress of this work.

Other changes done this year include the hiring of a lawn maintenance contractor to do our mowing. Prior to this we had volunteers doing the mowing work. I would like to thank all of the volunteers who did this work before we hired the service.

One of the effects of not meeting at the church is that the grounds don't get noticed much. In 2022 I hope we can bring back the Adopt a Plot program to get volunteers to maintain areas not covered in our mowing contract.

Other work that has been done this year includes putting rock along the sidewalk on the south side of the church. We also had a successful clean-up day in the fall to pick up leaves. This turned into more than two days since we had so many leaves. More of the dead trees on the east side of the parking lot were also taken out.

Replacement computers have been purchased for the office staff and are in the process of being prepared for use. We are also investigating cloud based solutions for our office needs to eliminate the need for a physical server in the office and the overhead required by the physical server.

Looking ahead to 2022, the Property Committee, in association with the Climate Care Team, has discussed replacing all the fluorescent bulbs in the building with LED bulbs to reduce energy costs. More landscaping work is also being discussed for the west lawn area.

The big project coming up is replacement of the flooring in Kempsell Hall. Peggy Broderick, Chris Linden, and Dave Burry have done a huge amount of work to get us ready for this improvement and the work should be done by summer of 2022.

I would like to thank the congregation for their great responses to our clean-up days and for all the other work you all do to keep our facilities in good condition. I look forward to working with all of you in 2022!

#### Search Committee

The Search Committee was formed last spring and we immediately jumped into the search process. We met every Monday most weeks through the summer and early fall. One of our first duties was to create and release a Parish survey to invite feedback on the important things at Christ the King. Once we had the survey results, we spent much of our time using the information to put together a comprehensive Parish Profile. There were many reviews before we released the final Profile.

After we had the Profile created and approved by the Diocese, we jumped into writing interview questions based on the Profile. We've gone through a few revisions here, even in the middle of an interview. We chose a few questions and participated in a Mock Interview with Canon Vanessa from the Bishop's office. The experience was good and we learned a lot.

As we got close to our initial deadline for applicants, we were informed that we had only received two applications. Canon Vanessa recommended we keep our posting open for another month since we weren't going to begin interviewing until Epiphany anyway. By keeping the posting open, we were able to get more candidates.

Currently, we are in the process of interviewing our candidates. We have been very impressed by the qualifications of all of the candidates along with those we have interviewed thus far. We anticipate presenting our top 2-3 candidates to the Vestry by the middle of February, but we believe our discernment process will be difficult.

Thank you for keeping us in your prayers throughout this whole process. We could not have done it without your support and the grace of God.

#### **Prayer Network - 2021**

The Prayer Network team are parishioners who daily devote time to pray for the needs of others. They receive requests to pray for members of Christ the King congregation, for members of parishioner's families and for friends, neighbors and concerns of the congregation, the community and nation. The Prayer Network team currently has 18 dedicated members who receive prayer requests through email or U.S. mail. Prayer requests are collected from the prayer request box in the narthex filled out by parishioners on Sundays after the church re-opened and by phone calls, emails & texts and then are sent out to the Prayer Network members. A Weekly Prayer List is prepared each Thursday night for the following week and sent out to the Prayer Network members from which they pray along with any additional prayer requests that come in during that week. Also any emergency prayer requests for parishioners at Christ the King or their immediate families are called down right away.

After starting the year making sandwich bags at CTK, we are now back in the kitchen at St. Peter's & St. Mary's. We will continue to put together bags at CTK but instead of sandwiches a hot item like chili or Mac & Cheese will be added at St. Peter's & St. Mary's. Following the guidelines from the diocese we are still in the 'grab-n-go' approach. There still is no Eucharist and we are handing out socks, blankets, sleeping bags etc. through the old front door portico, even though the clothes closet is closed. Tables and canopies plus patio heaters are set up on the front lawn. Guests can eat as they wait their turn for clothes or simply come by to pick up their meals to go. Social distancing is being practiced and masks are required. Most Tuesdays can usually use volunteers including ours. Please see me if you are interested in helping. These are wonderful folks and would welcome your assistance. Our Managing Director, LizWolfert does an outstanding job of making this operation run efficiently and is very good atwelcoming new volunteers, bringing them up to speed on what's needed and making sure they feel welcomed and useful.

Although we are not able to hold our usual fund raising events, St. Clare's remains on solid financial ground. We have been able to meet the demands for different equipment and our year end report shows that 94% of our expenditures go directly to operating costs. Many individual donations have been stepped up and are always most gratefully received. Blankets, socks, sleeping bags and any warm, winter clothing items are very much in demand. Our guests have lost many of the other sources for clothing and other necessities. If you are able to make any clothing donations (socks & underwear are always needed) just drop them off on the table by the kitchen at CTK and we will take them down with our meals.

Finally, as of January 15, our Chairman, John Putnam, from St. Timothy's will finish his term. Fr. Bill Kindel from Ft. Morgan will also be leaving after many years of service but he will continue to be our

registered agent with the state. And, my term on the Board has also expired. Although the bylaws allow me to serve one more consecutive term, I will have been on the Board for 12 of the last 14 years and I would love to give someone else the chance to serve. Again, many thanks and blessings to all who support, serve or have served and all who keep St. Clare's and our volunteers in their prayers.

#### Climate Care Team

The Climate Care Team was originated by Reverend Becky Brown in October of 2018. #### **Conversations on Racial Justice and Reconciliation**
